



<u>Summer Camps – COVID-19 Safety Plan</u> (Effective June 22, 2020)

This safety plan is based on the guidelines of the College of Speech and Hearing Health Professionals of BC; the BC CDC guidelines for Community Based Health Professionals and for Childcare Settings; and the Worksafe BC Protocols for Health Professions.

Social Distancing

Our primary method for keeping your children and our staff safe from COVID-19 exposure will be maintaining 2m social distancing between individuals. To facilitate this we have implemented the following:

- "bubbles" themed group room: each child will have their own individual defined and colour-coded space (or "bubble") that are spaced 2m apart and that they must stay inside.
- Each student will have their own personal materials provided for the duration of the group.
- Limited contact between staff and students- staff will be in the room, but will maintain 2 m distancing whenever possible. If staff need to be closer to students for safety reasons, staff will don non-medical masks.

Drop Off/Pick Up Procedures

Please escort your child to the **back door** of Speak Easy (around the right hand side of the building), and **wait** with your child at the door. **Please be cautious of the sidewalk that leads out to Uplands Drive!** Please respect the personal space of other families who will be waiting, by allowing them 2 m.

- Parents (or students) must answer COVID-19 screening questions and each student's temperature will be taken with a no-contact thermometer.
- Each student will be required to hand sanitize, and then move to their assigned 'bubble'.
- Pick up will be at the same door, 10 minutes prior to the end of group.
- Lynne will come to the door, to debrief the day's work with the parents.
- Each student be escorted to the door by Lynne, and asked to hand sanitize prior to leaving.

Sickness/Illness Symptoms

No student or staff may attend if they are displaying possible symptoms of any illness.

- If a student becomes ill during group, they will be separated from the group, provided with a mask, and their parent called immediately.
- Parents have a responsibility to arrange pick up for their child immediately
- If staff fall ill during a group, they will self-isolate as soon as possible and parents will be called immediately. If the entire group needs to be cancelled, refunds will be issued.
- Students will be encouraged to use a tissue to cover sneezes and to avoid touching their faces.



Personal Protective Equipment

PPE in the form of masks and gloves is not required when social distancing is maintained.

- If staff need to physically contact students for their safety, staff will be wearing non-medical masks
- If students have personal masks, they may wear them if they choose
- If they want one to wear, it will be provided

Cleaning

- We are using a non-toxic, unscented, anti-viral sanitizing solution
- All high-touch surfaces (e.g. switches, taps, door knobs) are already sanitized twice a day.
- The group room will be sanitized after each group.
- Any surface that becomes contaminated with bodily fluids will be immediately sanitized.
- The washroom will sanitized after each use.

Handwashing

As always, students will be required to wash or sanitize their hands:

- before and after eating
- after using the washroom
- after wiping their nose with tissues
- before and after using their water bottle

Snacks and Water Bottles

Students will bring a snack and personal water bottle

- If students need extra water, disposable cups are available
- Weather permitting, some groups may have snack outdoors
